AMHERST CENTRAL HIGH SCHOOL PARKING REGULATIONS INFORMATION SHEET

Driving and parking on school property is a <u>privilege</u>, **not a right**, given only to licensed drivers who abide by the rules of the Board of Education in this bulletin. Rules and information for which you will be held responsible are listed below. Due to the increase of students who drive and limited number of parking spaces available in the Westmoreland Lot, parking for students is on a first come, first served basis. If there are no student parking spaces available, students **MUST PARK** off campus. Read the rules carefully.

- 1) ALL CARS MUST BE REGISTERED IN THE DEAN OF STUDENT'S OFFICE TO OBTAIN A PARKING PERMIT.
- 2) SPECIFIC REGULATIONS ARE:
- 1) Amherst parking permit is to be prominently displayed on dashboard inside vehicle.
- 2) Cars must be parked ONLY in areas for which permit is good.
- 3) Students may NOT park in the <u>Front U</u>, <u>Washington Lot</u>, <u>Berryman Lot</u>, or <u>Amherst</u> Community Church Lot.
- 4) Maximum 10 miles per hour speed limit.
- 5) No unnecessary horn blowing, loud muffler, squealing tires or other forms of noise.
- 6) Students may **not** be in, **nor visit**, their cars during school hours.
- 3) PENALTIES FOR VIOLATIONS:
- 1) Detention

- 2) Warning Sticker
- 3) Police Ticket payable in Amherst Court
- 4) Vehicle towed at owner's expense
- 5) Loss of parking privileges
- 6) Loss of Jr/Sr Privileges
- 4) The person applying for the parking permit MUST hold and show proof of a valid driver's license, is familiar with the parking regulations covered here and that they will observe them fully. Signing the permission slip indicates acceptance of these parking regulations.

STUDENT PARKING

Student parking is permitted in the Westmoreland lot only. Those permit holders who park in the Westmoreland lot must:

- 1) Apply for a permit and have a parent or guardian sign the permission slip below.
- 2) Apply for only one (1) parking permit per person -- per school year.
- 3) Not park in handicapped spaces.
- 4) Obey all posted signs.

NOTE: If a student with a valid permit drives another car to school, that student is required to report the make and license number to the Dean of Student's office. The student will be given a temporary parking permit. Failure to do so will result in a violation.
